#### ACCOUNTANT, PAYROLL

- (2) Previous payroll processing experience.
- (3) Experience with computerized Accounting programs and H/R / Payroll programs.
- (4) Demonstrable computer proficiency.

**KNOWLEDGE, SKILLS AND ABILITIES:**

Ability to perform highly responsible duties necessary to support the District. Knowledge of the organization, operation, program and goals of the District. Knowledge of federal, state and School Board rules, regulations and policies. Strong organizational skills with ability to prioritize and respond timely and accurately to deadlines. Ability to maintain confidentiality. Considerable knowledge of office practices and procedures and operation of office equipment. Good oral and written communication skills. Effective use of business mathematics. Ability to exercise independent judgment in assigned duties and deal effectively with District personnel, outside agencies and the general public. Ability to utilize the computer for word processing, spreadsheet programs and other functions. Ability to schedule time and to handle multiple tasks in stressful situations. Accountants must have knowledge and skills in the application of accounting principles.

- \*(1) Assist in the preparation of IRS Forms W-2.
- \*(2) Assist schools in complying with applicable laws, School Board Policies and Union Contract regarding payroll compliance.
- \*(3) Collect, compile and process necessary employee payroll information as assigned.
- \*(4) Process information and maintain online records of payroll deduction items; Union dues, United Way.
- \*(5) Review records of employee status assignments, payroll benefits and other deductions.
- \*(6) Ensure accuracy of employee leave records.

## **ACCOUNTANT, NON-DEGREED (Continued)**

- \* (7) Verify employment and other income reports.
- \* (8) Prepare salary certification on retirees and process other employee leave benefit requests.
- \* (9) Assist in compiling relevant payroll data for budget preparation and other District functions.
- \* (10) Perform data entry of required information for processing all payrolls, including deductions and payments for such benefits as Social Security and State Retirement plans.
- \* (11) Maintain employee records for child support, garnishments and tax levies to include employee and agency contacts.
- \* (12) Disseminate payroll warrants to payroll vendors.
- \* (13) Assist in training school and District personnel in payroll procedures.
- \* (14) Review computer on-line information regarding employees' individual payroll information, to include hourly, salaried and contracted payments.
- \* (15) Assist with accuracy of information and processing of additional payments; in-service, supplements, retro pays.
- \* (16) Work with Risk Management regarding workers compensation pay to eligible employees.
- \* (17) Work with Human Resources regarding status changes on retirees, resignations, terminations and staff on unpaid leaves.
- \* (18) Check and verify accuracy of timecards with on-line data entry for payment of overtime following Fair Labor Standards Act, Union contract language.
- \* (19) Maintain positive effective working relationships with District / school personnel and coworkers.
- \* (20) Maintain confidentiality.
- \* (21) Use positive and effective interpersonal communication skills.
- \* (22) Report to work regularly and on time.
- \* (23) Keep supervisor informed of potential problems and unusual events.
- \* (24) Participate in training and workshop to update and increase skills.
- \* (25) Submit accurate reports in a timely manner and maintain all appropriate records.
- \* (26) Complete assignments with minimum supervision.
- \* (27) Perform clerical tasks related to payroll or other finance functions.
- \* (28) Demonstrate support for school or department and District goals and priorities.
- \* (29) Maintain financial accounts.
- \* (30) Sustained focus and attention to detail for extended periods of time.
- (31) Perform other incidental tasks consistent with the goals and objectives of this position.

### **PHYSICAL REQUIREMENTS:**

Light Work: Exerting up to 20 pounds of force occasionally and/or up to 10 pounds of force as frequently as needed to move objects.
